V. Support Service

V.A. Facility Update

John Linder provided the school board with a written report over: summer projects, Johnson Controls projects this summer (new Elementary School boilers and new Jr./Sr. High School HVAC in the commons paid for with the ESSER funds), and a transportation update.

Dr. Prososki noted that the Nebraska Department of Environment and Energy was out this spring to complete a Food Establishment Evaluation on our food service program. Based on their evaluation, there is about \$10,000-\$15,000 worth of facility projects that this district will need to upgrade over the next 3 years. Dr. Prososki said the district is starting to get quotes for this project. Dr. Prososki noted that this is a primary example of an unfunded mandate that the state puts on school districts and Nebraska is one of only five states where the state legislature does not provide funds for yearly building projects.

V.B. Personnel Items

Dave Kaster was recently hired as the assistant head of maintenance position.

V.B.2. Resignation

V.B.2.1. Tim Blecha - 1.0FTE - K-6 Special Education Teacher at the Conclusion of the 2021-2022 School Year

The school board accepted the resignation of Tim Blecha at the conclusion of the 2021-2022 school year with regrets. The school board thanked Tim for his years of service at Southern Public Schools.

V.C. Technology Update

Dr. Prososki said that he completed the E-Rate funding application for the 2022 fiscal year. The district will receive around \$20,500 from this grant. E-Rate funding can only be used for infrastructure projects (e.g., Internet, access points, and basic maintenance of internal controls) and not to purchase technology devices.

VI.B. Elementary Principal's Report

The elementary principal reported on the following items: current enrollment figures (3-Year-Old Preschool - 10, 4-Year-Old Preschool - 19, K - 19, 1st - 31, 2nd - 25, 3rd - 28, 4th - 22, 5th - 28, 6th - 22), summer school, working on the activity schedule, testing, and upcoming activity events.

VI.C. Secondary Principal's Report

The secondary principal reported on the following items: current enrollment figures (7th - 32, 8th - 29, 9th - 33, 10th - 29, 11th - 31, & 12th - 25), the last day of school on Friday, May 20, alternative school update, student elections, seniors receiving \$277,000 in scholarships, Honors night on May 3, graduation on May 14, and MAP testing incentives.

VI.D. Superintendent's Report

Dr. Prososki informed the school board about how the district has been working with Reinke Manufacturing on a \$75,000 grant to start a welding program at Southern. Next, Dr. Prososki went over the minutes from the annual preschool advisory meeting, and he shared the assessment calendar for the 2022-2023 school year. He noted that there are required state and federal assessment that school districts must administer on a yearly basis. Next, Dr. Prososki went over the Measures of Academic Progress (MAP) assessment results, and he said that this norm-

referenced assessment is a federal requirement. Then Dr. Prososki went over a final legislative report from the 107th Legislature, Second Session and one of the major items from this session is schools will now be required computer science classes in grades K-12 during the 2024-2025 school year. Dr. Prososki informed the board that he was elected as President-Elect-Elect of Region I, Nebraska Association of School Administrators (NASA) for the 2024-2025 school year. Dr. Prososki went over the preliminary staff salaries for the 2022-2023 school year, and he said the district still needs to hire a K-6 special education teacher for the upcoming school year. In addition, Nicole Stevens will be serving as the interim vocal music teacher for 2022-2023. Lastly, Dr. Prososki noted that staff salaries account for roughly 85% of all school budgets in Nebraska and the other 15% of school budgets are fixed costs (e.g., Utilities, fuel, Internet costs, etc.).

VII. Items for Discussion, Consideration, and/or Action

VII.A. Set Activity Prices for the 2022-2023 School Year

Motion to keep the activity prices the same as the previous school year. This motion, made by Jim Zvolanek and seconded by Angela Meyer, passed. yes: 4, no: 0, Absent: 2

The admission prices for the 2022-2023 school year will be \$5 for adults, \$4 for students. The prices for passes for the 2022-2023 school year will be \$50 for adults, \$30 for students, and \$90 for families. These are also the same prices that the other Pioneer Conference schools charge.

VII.B. Approval of Milk Bids for the Southeastern Nebraska Milk Cooperative for the 2022-2023 School Year

Motion to approve the escalating and de-escalating milk bid from Hiland Dairy for the 2022-2023 school year. This motion, made by Dana Dorn and seconded by Jim Zvolanek, passed. yes: 4, no: 0, Absent: 2

Southern Public Schools is a member of the Southeastern Nebraska Milk Cooperative and the purpose of the cooperative is to achieve lower milk prices in an effort to save the district money. The Southeastern Nebraska Milk Cooperative consists of the following districts: Diller-Odell, Fairbury, Meridian, Southern, Tri County, & Wilber-Clatonia. The milk bid for this year was \$0.10 cents higher than the previous year and the district will need to raise our milk prices for the 2022-2023 school year to keep up with inflation. The district is still working on trying to get free breakfast and lunch over the next 4 years (2022-2023 to 2025-2026).

VII.C. Board of Education 403(b)/457(b) Resolution

Motion to approve the Board of Education 403(b)/457(b) Resolution. This motion, made by Dana Dorn and seconded by Angela Meyer, passed. yes: 4, no: 0, Absent: 2

By passing the Board of Education 403(b)/457(b) Resolution, Southern staff members can participate in an employee tax-sheltered annuity for the 2022-2023 school year. There will also be no added cost to the district by starting this program.
